Thank you to John Bessey, Karen Hoisington, Teri Morris, and Fred Johnson for serving on the Nominating Committee this year. It went very smoothly. They are confident in their list of candidates and see it as a sign of the Holy Spirit's presents that they were able to arrive at this list so quickly.

This is the report, respectively submitted by Jim Hall, the vice chairman of the Elder Board and the entire Nominating Committee.

Deacon - entrusted with physical welfare of church; must meet biblical qualifications for deacon.

Elected for up to 3 years. Holds in trust all church properties, etc. Prepare annual budget, care for church property, provide ushers. Nominees are Chris Bowlby, Jonathan Martinez, Chris Peters, Patrick Lavey, and Chuck Davis. Deaconesses - Nominees include Patricia Galdamez, Lorraine Allen, and Elaine Davis.

Elder Board Report Phil Zirges

Elder - oversight along with pastoral staff of all aspects of church life; lead and govern the church, teach and defend sound doctrine, administer discipline, etc; meet biblical qualifications for elder.

Current elders are Jim Hall, Joe Diaz, Juan Reyes, Edgar Galdamez, Terry Hall, and Phil Zirges. Edgar and Juan had a wonderful 1st year serving on the board and we were grateful and pleased to have them.

Elected up to three years; oversee nominating committee, authorize disbursements from the benevolent fund, etc.; nominees are Bob Chambers, Juan Reyes, Edgar Galdamez, and Terry Hall Review of this past year:

- Keeping up with the Benevolent Fund (a one-time gift) and the Acts 4 Fund (a long term ministry). A lot of economic changes are going on in our country, which has affected Village this year as well. These ministries have been a great help and support to those in our congregation who are in need of financial assistance at this time.
- Attempted to build a Spanish speaking church service. The timing just wasn't right.
- Started the VBC Photo Gallery in March 2015. Photos can be downloaded of Village Events throughout the year.
- We have experienced some budget deficits this past year. In December 2014 we were 14,000 under budgeted giving. This was cause for concern. We were not able provide some of the income adjustments that we had planned, this we very disappointing. We can still see how God continues to be faithful. Looking Forward:
- Looking forward to having Bob Chambers serving on the Elder Board this year. Very gifted and called to be a part of this Board.
- Everyone looking forward to Pastor Andrew's Ordination
- Elders will continue to clarify our vision statement and goals. Looking at not just what can we do, but what should we do.
- Desire to pay off church's loans and freeing up more resources for ministry.

Children's Ministry Report Andrew Bessey

Overview of work done on the campus Upcoming projects that are fully funded

- Gym roof repair funded, but being delayed until needed
- Kitchen flooring to be re-done funds have been set aside

Presentation of General Budget -John Bessey

Review of budget, entertain questions about general budget, staff will be dismissed, questions about staff salaries, staff recalled, voting on budget Reminder - will adhere to Robert's Rules (one person at a time, wait to be acknowledged, address chairman not each other)

Thanks to budget committee: JoAnne Hall, Lorraine Allen and Chris Peters, Jacob Ailes, Edgar Galdamez, Joe Diaz and Ron Johnson (in advisory role)
-This has been a very smooth process. The Budget came together in two meetings. Budget is based on projections through the end of April. It is projected to come in \$1,998 over budgeted undesignated giving. We are also \$4,620 under budget in expenses. Due to this \$6,000+ additional surplus, we allocated \$5,000 back into major repairs. Part of those funds will go towards:

- Re-striping the parking lot
- Adding a speed bump to the drive way entry (will help with drivers as well as flooding)

Packet that was sent out included a PAQ (Probable Asked Questions) and a Q&A meeting was held to answer questions. Floor opened for questions.

How do we come up with a proposed budget? Refer to PAQ in packet for description.

Staff dismissed

Senior Pastor - last year received a 0% salary increase. This year a slight salary increase of 2%

Associate – last year received a 0% salary increase. This year there is an increase of 17.1%.

This is 70% of the Senior Pastors salary, which keeps us just one year away from our original goal of 80% salary rate of the Senior Pastor by 2015-2016. This year that is an increase of \$8,664 over the year.

Medical insurance premiums are 4% higher this year. They are currently on Medishare.

Staff secretary – Last year no increase. This year 2.1%. That is an increase of \$165

Additional Staff salary (worship director) – Last year no increase. This year 2.2%. That is an increase of \$82.

Ministry Intern – A new position last year. This year there will be a 2.1% increase. No questions or concerns about Staff Budget.
